



## **ASSUMPTION OF RISK and WAIVER OF LIABILITY**

### **COVID-19**

PLEASE READ THIS DOCUMENT CAREFULLY AS IT AFFECTS YOUR LEGAL RIGHTS.

A parent or guardian of a child enrolled or to be enrolled with Pris-T-giS Montessori School (the “School”) must complete and sign this Waiver for himself/herself as parent, guardian and on behalf of the child and his/her family. Please initial every page.

1. I am fully aware of the risks and hazards inherent in the attendance at the School premises and participation in School programmes in terms of contracting or spreading COVID-19. Such risks may result in personal injury, illness, permanent disability, death, inconvenience, expense, damage and other loss.
2. I fully understand and acknowledge the risks of becoming exposed to or infected by COVID-19 at or around the School premises, which risks may result from the actions, omissions, or negligence of myself and others, including but not limited to the School, its principals, staff, contractors, volunteers, other children and their families, however arising.
3. I freely and voluntarily assume all risks and hazards of death, personal injury or property damage, as set out hereinbefore as well as those not specifically described therein, whether anticipated or unforeseen, and accept sole responsibility for any injury or liability of any kind that I or my child or our family may experience or incur in connection with my child’s attendance at the School or participation of any programmes offered thereby.
4. On my behalf, and on behalf of my child and our family, I hereby release, waive, covenant not to sue and forever discharge the School, its principals, staff, contractors, volunteers, of any and all claims, actions, damages, costs or expenses of any kind arising out of or relating to the risks described herein. I understand and agree that this release includes claims based on actions, omissions or negligence (active or passive) of the School, and whether a COVID-19 infection occurs before, during or after attendance at the School.
5. I agree to indemnify the School from any and all third party claims, howsoever arising, for any loss, liability, damage or cost the School may incur, including but not limited to, claims arising in whole or in part by my or my child’s negligent or intentional acts or omissions while participating in School programmes.



6. I further agree to indemnify and hold the School harmless from and of all claims, proceedings, demands, suits or actions, costs and expenses (including legal fees) incurred by the School, which may be brought against the School for any reason resulting from my child's attendance at the School.
